

Terms and Conditions

1. 'Mountain Dew x MapleStory offer' ('Promotion') is brought to you jointly by PepsiCo International Pte. Ltd. and Etika Pte Ltd ('Organizer').
2. Promotion is valid upon a valid receipt showing purchase of Mountain Dew 500ML and 1.5L, Pepsi 500ML and 1.5L, 7Up 500ML and 1.5L, Mirinda 500ml and 1.5L, Mirinda Mix-It 500ML, Mug Root Beer 500ML, Gatorade 515ML, Lipton Ice Tea 500ML and 1.5L only ('Products').
